Group Transmission</b> - Risk of transmission between visitor and school staff / children <b>on arrival and departure</b>	Visitors, adults and children at risk of cross contamination through direct and indirect contact with others and with surfaces	<p>All visitors to book appointment with the school, so that arrival can be carefully managed at the agreed arrival time. No unexpected visitors will be able to access the school site without prior consent.</p> <ul style="list-style-type: none"> <li>• Visitor greeted in reception area at 2m distance</li> <li>• Staff complete sign in for visitor under usual procedure with additional request of contact details (phone number) for Track and Trace</li> <li>• Visitors to read the schools COVID statement and sign to say this has been understood</li> <li>• Copy of the schools Risk Assessment will be available upon request</li> <li>• Visitor sanitises hands on entry</li> <li>• Visitor is escorted to area of work, limiting contact with other adults or children where possible</li> <li>• Outdoor access to available working space will be used where appropriate, to avoid contact with other pupils and staff</li> <li>• On exit, visitor to be escorted to exit, hands sanitised, school staff sign them out</li> </ul>	<p><i>Ensure all new guidance is followed and risk assessment updated in line with government and HSE guidance</i></p>	<p><i>All Staff/ Admin Staff/ SBM/ Head teacher</i></p>	<p><i>September 2020</i></p>

Group Transmission –</b></p> <p><b>Lack of social distancing using toilets and poor hygiene</b> resulting in direct and indirect transmission of the virus</p>	<p>Visitors, adults and children at risk of cross contamination through direct and indirect contact with others and with surfaces</p>	<p>Where possible visitors to avoid using toilet facilities</p> <p>Where these must be used, visitor should take the most direct route to toilets, avoiding contact with children and staff. Hands should be sanitised before movement through school and on entry to the toilet, occupied sign on door must be used.</p> <p>Rigorous hand washing must be completed</p>	<p><i>Site manager/ cleaning staff aware of visitor on site and toilets cleaned after use</i></p>	<p><i>All Staff/ Site manager</i></p>	<p><i>Immediate procedure in place to be actioned when visitors on site</i></p>	
<p><b>3. Group Transmission –</b></p> <p><b>Lack of social distancing when working within the building</b></p>	<p>Visitors, adults and children at risk of cross contamination through direct and indirect contact with others and with surfaces</p>	<p>When working with school staff, visitors must work in a spacious well-ventilated area, at 2m from other adults.</p> <p>Contact with school staff / children should be minimised, with only essential contact.</p> <p>Face masks to be worn in the school building</p> <p>Where used, tables / chairs / resources to be sanitised after use</p> <p>Face masks are to be worn when inside the building</p> <p>Face to face contact to be limited as much as possible</p>		<p>SMT/ Head Teacher</p>
